

**Minutes of 127th Meeting of Accommodation Allotment
Committee No. II**

The 127th Meeting of the AAC-II was held in the Conference Room of the Dean (IPS) office on 20/01/2012 at 2.30 P. M.


Prof. N. Venkataramani and Prof. Anindya Duta were present as invitees.

Shri T. P. Ravindranathan was present to assist the Committee.

- 1) Chairman along with other committee members thanked the outgoing Chairman, AAC- I & II, Prof. N. Venkataramani, for valuable contributions made by him during his tenure.
- 2) Allotments made during the intervening period of AAC-II were presented to the Committee for formal approval. The committee granted its approval.
- 3) The application of Shri D.K. Dubey, Watchman, Security Section was considered on Medical Grounds for allotting a quarter in the ground Floor. It was decided to allot an H2 ground floor quarter.
- 4) The committee discussed the letter forwarded by the Chairman, H.C.U. regarding certain issues raised by the mess workers regarding the allotment of quarters from the general pool to them. The committee reiterated that the BOG resolution of allotment of one quarter in a block of ten quarters to a mess worker will be respected and mess workers' quarters would be absorbed in the general pool of accommodation of the Institute. Allotment of quarters to mess workers would henceforth be administered by AAC-II
- 5) It was decided that in order to implement the BOG resolution of assuring one out of ten allotments of residential quarters to mess workers following procedures would be followed:
 - a) First quarter in a block of ten quarters will be reserved for an SC/ST employee.
 - b) If the first quarter of a block is allotted to an SC/ST mess worker by virtue of her/ his seniority, then second quarter or next quarter available for circulation in the same block will be reserved for an SC/ST Institute employee. Further, mess workers will not be allowed to apply for the second quarter and all subsequent eight quarters of the same block.

- c) For a given quarter in a block of ten quarters employees of institute as well as mess workers will be allowed to apply if any earlier quarter in that block has not been already allotted to a mess worker, and the quarter in question will be allotted based on the seniority of applicants.
 - d) Once a quarter in a block of ten quarters has been allotted to a mess worker, mess workers will not be allowed to apply for all subsequent quarters in that block.
 - e) In a block of ten quarters if all the nine quarters have been allotted to institute employees then the tenth quarter in that block will be reserved solely for a mess worker.
 - f) Starting from the first quarter of first block to the first quarter of the tenth block if none of the quarters has been allotted to an SC/ST mess worker by virtue of seniority, then in the tenth block from the second quarter onwards institute employees and only SC/ST mess workers will be allowed to apply. In the process if a quarter is allotted to an SC/ST mess worker then for all the subsequent quarters mess workers will not be allowed to apply. If second to ninth quarters of this block have not been allotted to an SC/ST mess worker by virtue of seniority, then the tenth quarter of this block will be reserved for an SC/ST mess worker.
- 6) Based on the aforementioned resolutions, quarter no. H1-1 circulated for SC/ST would be allotted to an SC/ST Mess Worker as he is the senior among the all the applicants. And hence applications received from mess workers against the general circular for H1-7, H1-117 & H1-118 would not be considered, since H1-1 in this block of 10 was going to be allotted to a mess worker. Further, the next available vacancy in this block would be reserved for Institute employees belonging to SC/ST category.
 - 7) It was decided that the certification with regard to SC/ST status of mess workers would be forwarded by the Chairman, H.C.U.
 - 8) The Chairman, H.C.U. had requested the committee to allot the eight newly reconstructed Mess Workers Quarters in the toilet block of MW-1 to mess workers, since these quarters were under construction/renovation for a long period even before the BOG passed the resolution regarding the allotment of quarters to mess workers from the general pool.. The committee considered the same & acceded to the request and requested Chairman, HCU to allot the aforementioned eight quarters to mess workers.
 - 9) It was decided that all erstwhile mess workers quarters would henceforth be considered as quarters belonging to Type 1 category.
 - 10) It was decided that if it was found for a quarter for which applications were sought under Institute employees pool, there were no applications from an eligible employee of the Institute, then that quarter would be again circulated for the second time, this time, for both Institute employees and mess workers. If again there were no applications from eligible employee of the Institute, then that quarter would be allotted to a mess worker.

It was decided that if it was found for a quarter for which applications were sought under mess workers pool, there were no applications from an eligible mess worker then that quarter would be again circulated for the second time, this time, for both Institute employees and mess workers. If again there were no applications from mess workers, then that quarter would be allotted to an Institute employee and the mess workers' quota would not be entertained in that block of ten quarters.
