Congratulations! I am glad to inform you that you have been **PROVISIONALLY** selected for **M.Tech. Programme** in (check status on the Online Application portal) Department/ Schools/Centres/ ID Groups under **Teaching Assistantship (TA) category**.

To **CONFIRM** your admission, remit the following fees by **SBI Banking/ CANARA Net Banking through Online payment process**.

Fees for all categories (GN/OBC/OBC-NC/SC/ST/PwD) :
(Revised Fee as per circular No. REG/A-2/2017 dated 12th April, 2017)

For GN/OBC/OBC-NC category :

With Hostel Accommodation = Rs. 32,600/-
Without Hostel Accommodation = Rs. 22,100/-

For SC/ST/PwD category:

With Hostel Accommodation = Rs. 27,600/-
Without Hostel Accommodation = Rs. 17,100/-

If you have opted for Hostel Accommodation then you are required to submit the Mess Advance of Rs. 20,000/- through an additional demand draft drawn in favour of “**The Warden, Students Hostel, IIT Bombay**”. This should be directly submitted to the concerned Hall Manager by the candidate, at the time of joining the Institute hostel. The hostel allotment details will be displayed by Hostel Co-ordinating Unit (HCU) 3 or 4 days prior to the date of registration. The candidate shall directly contact the Hostel Co-ordinating Unit(HCU), Ground Floor, Main Building, IIT Bombay on 022-25768900 or email at hcu.office@iitb.ac.in, for all hostel related queries. Please note that the Institute provides accommodation on campus strictly for the stipulated duration of Programme under which one is admitted. **Accommodation is provided to TA category students on the campus and at times, due to shortage of rooms, they may be required to continue with “sharing accommodation system”.**

As per MHRD directives, a student holding Teaching Assistantship (TA) / Research Assistantship (RA)/ Teaching Assistantship through Project (TAP)/ Research Assistantship through Project (RAP) shall not accept or hold any appointment paid or otherwise or receive any emoluments, salary, stipend from any other source during the tenure of their programme.

Please note that if this offer is for the choices other than your first choice, then you still have the option for attending Written Test and/or Interview as per the schedule given on the Institute website _ for admission to your higher choices. However, **NO CLAIM** for this offer will be entertained after the last date of payment of fees {i.e. by 21st May, (12:00 midnight)}.

In case you CONFIRM your admission by paying the requisite fee as per the THIRD OFFER (Direct Admission on the basis of GATE score), your candidature will still be considered for your higher choices/preferences and if applicable you will be transferred to your higher choice / preference AUTOMATICALLY in the subsequent offer, IF ANY. It may please also be noted that in case a candidate has not confirmed his/her seat by paying fees after the first/second direct offer of admission his/her candidature will still be considered for higher choices/preferences and accordingly a fresh offer for direct admission (IF ANY) will be made to the candidate.

Please note that fees already paid towards confirmation of admission under FIRST/SECOND OFFER will be adjusted against the THIRD OFFER (Direct Admission on the basis of GATE score). However, the candidate who has not paid fees at the time of first /second offer and is finding place in the third list, has to confirm his/her seat by paying stipulated fees.

In case a candidate from the direct admission offer list gets selected for admission through Written Test and/or Interview then the fees received will be adjusted on his/her **REQUEST ONLY** for transfer of fees paid and the admission will be **CONFIRMED** accordingly.

Moreover, the candidate may also attend "On the Spot Admission" if any, as per the schedule announced on admission site for any specialization/ preference, subject to fulfillment of required criteria.

The Registration & Orientation Programme is scheduled during **July 13, 2017 to July 15, 2017**. You are required to report at 9:30 a.m. on **July 13, 2017** for registration. You are advised to refer <http://www1.iitb.ac.in/academic/mtech.jsp> in the 1st week of July, 2017 for more details on 'Registration and Orientation Programme'. Attending the Registration & Orientation Programme for TA category students is **MANDATORY**. **Classes for the Autumn Semester 2017-18 begins from July 17, 2017.**

Verification of documents/certificates will be held on **31st July, 2017** in the concerned academic units. You are required to bring self-attested copies of your Educational qualification, Date of Birth, Migration, Caste/Tribe /Non-Creamy Layer/Disability certificates, etc. along with **ORIGINALS** for verification.

You are also requested to submit the "Vaccination Certificate/Vaccination Exemption Certificate" at the time of registration. You may be allowed to register with the partial vaccination, if done, however you will be required to complete the vaccination during the first semester. Registration for the second semester will be subject to complete vaccination as required. Please refer to <http://www.iitb.ac.in/newacadhome/mtech.jsp> for proforma of "Vaccination Certificate/Vaccination Exemption Certificate".

Candidate whose qualifying degree (B.E./B.Tech./M.Sc. etc.) is not yet completed or whose results are awaited, shall bring a certificate from the Head/Principal of the Institute/College about the status of the final examination. **However, they must submit passing certificate and proof for having First class or 60% marks (55% for SC/ST) in qualifying degree examination by 31st July, 2017, failing which the admission will stand cancelled (please refer to A.7. "ELIGIBILITY FOR M.TECH./M.TECH.+ Ph.D. (DUAL DEGREE) PROGRAMMES" of M.Tech. Information Brochure 2017-18).**

The Institute reserves the right to withdraw the admission at any stage/time in case a candidate does not fulfill the requisite qualification and/or percentage of marks in qualifying degree or supplies any false information.

Candidates wishing to cancel/withdraw admission after paying the requisite fees **MUST** communicate the same by an email given in the application form to pgadm@iitb.ac.in stating subject **"CANCELLATION OF M.Tech. ADMISSION 2017-18- DA (3rd offer)"** by specifying the department and specialization OR you may fax the same to Jt./Asstt. Registrar (Academic) at 022-2572 3480.

E-mail regarding cancellation/withdrawal of admission will be entertained, **ONLY IF**, the request is made through E-mail ID given in the Application form.

The fees will be refunded after deducting processing fees of ₹ 1000/- from the total fees, only if such request is received by **30th May, 2017** and the candidate in the waiting list pays the fees and confirms the admission for the seat VACATED by you. In other cases, only refundable deposits of ₹ 2,000/- or ₹3000/- (**plus the hostel fees paid, if any**), will be refunded. The refund will be send to the respective candidate's Bank account (through which they have debited/paid the admission fees) by NEFT within ONE month time from receipt of such e-mail/ request, after verifying the details.

Motorized vehicle of any type for the students on the Institute campus is strictly prohibited, excepting medical cases as required.
